PORT-AU-PRINCE -- Après une séance marathon dans la nuit de samedi à dimanche au parlement, les sénateurs et députés haïtiens réunis en Assemblée Nationale, ont élu Jocelerme Privert président provisoire d'Haïti, avec la mission de nommer un Premier ministre rassembleur dont sa tâche principale consiste à compléter le second tour de la présidentielle reporté sine die le mois dernier, suite aux contestations de l'opposition qui accusait l'ancien chef de l'état Michel Martelly de vouloir fomenter un "coup d'état électoral" en faveur de son poulain Jovenel Moise,

candidat sous la bannière du Parti Haïtien Tet Kale (PHTK).

Jocelerme Privert, 62 ans, qui était jusqu'à la soirée du samedi 13 février le président du sénat s'est vu confier la gestion du pouvoir exécutif. C'est la première fois depuis 1946 qu'un chef de l'État haïtien est choisi par une élection indirecte.

Dans un premier tour assez serré, Privert a obtenu 13 votes des sénateurs et l'ancien président du sénat, Edgard Leblanc Fils, en a récolté 10.

# 'We're back' - Aristide allies toast Haiti's interim president at palace

A senator who served as interior minister under former president Jean-Bertrand Aristide was sworn in as Haiti's interim president on Sunday, a development met with elation by allies of the leftist leader who days ago were leading street protests.

Haiti cancelled a runoff presidential election in January amid often-violent protests over alleged fraud in the first round and after the opposition candidate boycotted the vote.

Former president Michel Martelly finished his term a week ago with no elected successor as a result. Instead, a deal was struck for the opposition-controlled parliament to choose a provisional president to oversee fresh elections quickly.

Factions of Aristide's Lavalas movement were heavily represented at the ceremony for President Jocelerme Privert, 63, at Haiti's national palace, which some had not visited since the ex-president was toppled 12 years ago.

"The last time I came to the palace was in 2003 when President Aristide was in power," said Ores Nixon, a street activist with a Lavalas splinter party who lives in the Bel Air slum in the capital, Port-Au-Prince.

"Now look at me, inside the national palace with a glass of champagne, celebrating the inauguration of our President Jocelerme Privert," he said.

By contrast, the ceremony and reception on the lawns of the building devastated in the 2010 earthquake were thinly attended by supporters of Martelly, or his party's candidate.

Aristide remained a potent symbol for the poor until the present crisis, but his influence was seen as fading

as the movement he founded splintered into bickering factions and he largely vanished from public life.

As protests against Martelly and the elections gathered steam the factions reunited, however short-lived that may be.

Aristide's wife was at the ceremony in a rare political appearance, as was the current Lavalas presidential candidate.

"We have shown that we are able to overcome our differences and our infighting in the benefit of the general interest," Privert said at the swearing-in.

Privert is a member of the Inite political party founded by ex-president Rene Preval, another estranged Aristide acolyte.

Privert vowed to engage all sectors in dialogue to complete the elections after an evaluation of the fraud allegations, and hand over to an elected president by May 14. Elections are set for April 24 under the deal struck last week.

After Aristide, a former Salesian priest, was forced from power by armed rebels in 2004, Privert was thrown into prison for two years on charges he organised a massacre of

the president's opponents. The charges were later dropped.

One of the major challenges ahead will be to reach an agreement about who can participate in the election, with many parties rejecting the October results that led to a two-man race between opposition candidate Jude Celestin and ruling party favourite Jovenel Moise.

Activist Andre Fadot, who has led protests in favour of Celestin, was more cautious in his support of the interim government, warning at the palace on Sunday that free and fair elections should happen quickly.

It took two years to hold elections the last time there was an interim government in Haiti, after Aristide's ouster.

"Our presence here means Lavalas and Aristide are back in the palace. We are back in power and we won't let it go," said Lavalas supporter Clausel Romey.

## United Nation welcomes election of provisional President in Haiti

UNITED NATIONS, Feb 16, CMC – United Nations Secretary General Ban Ki-moon has the election on Sunday of Jocelerme Privert as the interim President of Haiti.

Privert's election by the National assembly comes one week after the departure of former President Michel Martelly.

Opposition parties had boycotted the second round of elections to on January 24 to elect a successor to Martelly, accusing the Provisional Electoral Council (CEP) and Martelly of wanting to rig the polls in favour of the government backed candidate.

"This election stems from the agreement signed on February 6 between Haitian stakeholders to preserve institutional continuity and further the electoral process," according to a statement issued by Ban's

spokesperson.

In welcoming this "crucial first step," the UN Secretary-General urged all parties to work together towards the implementation of the roadmap contained in the agreement "to ensure the return to constitutional normality.

"The Secretary-General expresses his confidence that the stabilization of Haiti and the democratic process will continue in a peaceful and collaborative manner," the statement said.

Privert will serve as interim President for 120 days.

"[The] election is a fundamental step in the implementation of the Political Agreement for institutional continuity, signed on February 5 between the branches of the executive and legislative branches of power," said the UN Special Representative in Haiti, Sandra Honoré, in a

joint statement with other members of the international community represented in the so called "Core Group" – Brazil, Canada, Spain, France, United States, European Union and Organization of American States.

The Group reiterated its invitation to all stakeholders to work together in achieving this political agreement, "to ensure the return to constitutional normality, stabilizing institutions of the Republic, the appointment of a consensus prime minister and the continuation of the electoral process on time."

The UN and its partners in Haiti also called on all stakeholders to uphold the best interests of the country, in a spirit of dialogue and compromise, and in a peaceful, violence-free climate.

## South Florida declares Zika emergency

MIAMI-DADE -- On Feb. 3, the Surgeon General of Florida declared a public health emergency in Broward and Miami-Dade Counties due to reported cases of the Zika virus, which may lead to Guillain-Barre Syndrome and birth defects.

According to Miami Herald, as of Feb. 11, 16 people have tested positive for the virus in Florida, six of whom are in Miami-Dade and two of whom are in Broward. All cases are travel-related.

Although none of the reported cases in Florida were contracted in the continental U.S., officials have expressed concern that the virus will spread in the counties that those infected reside in, including Broward, Hillsborough, Lee, Miami-Dade, Osceola, Santa Rosa and St. Johns.

The mosquito species *Aedes aegypti*

and *Aedes albopictus* carry and spread the virus through bites. Symptoms are generally mild and include fever, rash, joint pain and red eyes.

Bindu Mayi, associate professor of microbiology, said that, because symptoms are mild, many people don't realize they're carrying the virus.

Mayi said the best way to respond to mosquito-borne diseases is using mosquito eradication techniques, such as insecticides and repellants that contain DEET or picaridin.

"Use [the repellants] as the manufacturer recommends so you minimize any adverse effects," she said.

Miami-Dade Mayor Carlos Gimenez sent out a memo to the Board of County Commissioners that outlined the procedure of the Department of

Solid Waste Management's Mosquito Control Section in Miami-Dade.

The mayor said that, if necessary, the DSWM's Mosquito Control Section will spray EPA-approved insecticides in areas with high concentrations of mosquitos.

Though symptoms are mild and often go away, pregnant women who contract the virus may pass the virus on to the fetus. This could lead to a birth defect called microcephaly, where the baby's head and brain are disproportionately smaller than expected, and other disabilities.

The first confirmed case was in Brazil in May 2015, and Brazil says nearly 4,000 babies have been born with Zika-related microcephaly since October 2015, according to BBC.

Mayi also said scientists are researching the connection between the virus and Guillain-Barre Syndrome, a non-contagious disorder that attacks the peripheral nervous system, which may cause extreme weakness or paralysis.

There are currently no vaccinations available to prevent the virus. It is recommended that people wear long-sleeved shirts and long pants, stay indoors when possible, use EPA-registered insect repellants, and treat clothing with permethrin.

Mayi also recommended that people living in South Florida should drain any stagnant water they keep in or around their homes, as stagnant water is typically a breeding location for mosquitos.

# Haitian Migrants Pouring Into Brazil Don't Find A Warm Welcome

When 26-year-old construction worker Alex Mustivas was injured on the job in Brazil, fracturing his spine and arm, his employer offered him \$70.

"If you want it, take it," the construction company's owner told him. "If you don't want it, you don't want it."

Mustivas, who had been doing the job off the books, refused the money. "I told him that my life is worth more than \$70."

With the support of unions in the state of Santa Catarina, Mustivas was able to receive social security for a month. He says he couldn't get up or walk for a few days. "After a week, I was able to walk and stand up by myself," he said.

A year ago, Mustivas came to Brazil from Haiti. His home country is still recovering from the devastating earthquake in 2010, and he arrived in Brazil in search of better work opportunities.

It wasn't too difficult to find this construction job, Mustivas said.

"The boss used to pay me \$18 a day, but he didn't want to sign my work permit. He kept saying that he would sign it the following week, but he never did. I had to pay rent and help my daughter," said Mustivas, whose 7-year-old daughter lives with her maternal grandparents in Haiti. "I couldn't be unemployed."

He is currently living in the state of Curitiba, where he works as a security guard at a private university and plays in a band. "I thought there would be more people to look after me," he said.

Mustivas is one of 65,000 Haitians who arrived in Brazil between 2011 and November 2015, according to data from the Federal Police.

According to the police, 3,500 Haitians are registered in Santa Catarina, but the numbers are likely much higher.

"The records we have here are only those who have requested refuge in Santa Catarina, but most did in the state of Acre," explains delegate Ildo Rosa. In July 2015, the government estimated that between 4,000 and 6,000 Haitians actually live in Santa Catarina.

"According to the Ministry of Labor and Employment, Haitians became the group of immigrant workers with the largest presence in Santa Catarina's formal market in 2013," explained Professor Gláucia Assis, coordinator of the Center for Migration Observation in Santa Catarina, which is affiliated

with Santa Catarina State University. The center estimates that around 7,000 Haitians live in the state.

In the first five months of 2015, 2,259 work permits were issued to Haitians in Santa Catarina, more than double the number of permits given out in 2014, according to the Ministry of Labor.

Assis says the influx can be explained by the strong social networks in Haiti, which allow immigrants to pull others to Brazilian cities.

"This increased presence of Haitians in the state is due to the fact that the majority came and found work before the economic crisis intensified," Assis said. "It is also especially attributed to the fact that immigrants, once they are established and find work, tend to pass that information to their friends and relatives, who are more likely to go to a place where they know someone who is established and can help them find employment and housing."

It was the prospect of a job and the possibility to further his studies that brought 28-year-old Alexandre Bladimy to Balneario Camboriu.

Bladimy worked at a refrigeration company in Rio Grande do Sul for a year before he was dismissed. After a year of unemployment, he started studying international relations at the University of Vale do Itajaí, where he works in the Department of Inclusion to help his fellow Haitians.

Bladimy, who had worked as the manager of a technical school in Haiti and gave language classes, criticized the lack of public policies serving Haitians in Brazil.

"The government is promoting a foreign policy to bring more Haitians to

Brazil, but there is no public policy for Haitians here," said Bladimy, who says he was invited to come to the country even though he had a good job in Haiti. He is now preparing to return to Haiti.

"It wasn't too bad for me there," he said. "I used to make decent money, so I was able to pay for my ticket. A lot of Haitians come here to look for work, but I had a good life there. It was the good offer that persuaded me to come. I had hoped for better opportunities here, mainly in terms of being able to further my studies."

Assis points out that the lack of public policies to address immigrants, as well as the differences in culture, way of life and language are often factors that disappoint Haitians who move to Brazil.

"Situations like these show immigrants that the country that used to promote a welcoming image abroad is actually not that welcoming -- especially when the immigrant comes from a poorer country and is black," Assis said. "Haitians are affected by racism in various everyday situations, like when they take a bus, and in gaining access to the labor market and to public services."

The Ministry of Justice said that in addition to increasing Brazil's capacity to issue visas to Haitians and thus trying to discourage illegal routes, it has been creating an action plan with states, municipalities and other ministries to support immigrant integration.

National Secretary of Justice Beto Vasconcelos signed an agreement with the state of Acre to transfer resources and transport foreigners to other regions with more available jobs, such as Sao Paulo, Parana, Santa Catarina and Rio Grande do Sul. The project, which has a budget of approximately

\$500,000, seeks to facilitate coordination among federal, state and local governments.

In an interview with HuffPost Brazil last year, Vasconcelos said the Haitians arriving in Brazil "can definitely be absorbed into Brazilian society."

However, with the gap left by the state, it falls upon civil society to receive and help Haitians, explained Assis. In light of this dynamic, some government initiatives aim to recognize the work of civil society.

In the Balneário Camboriú City Council, a project is underway to recognize the Association of Haitians in Balneário Camboriú, or ASHABC, as a public entity. When the project is complete, ASHABC would be required to submit annual reports to the Municipal Legislative Branch.

"The organization's work allows us to better evaluate the factors that cause migration and the opportunities these immigrants have in Balneário Camboriú," said project founder Peter Francez. "In the absence of public policy, the ASHABC is in fact occupying a space that should be occupied by the government. The association has been active in receiving, forwarding and managing opportunities for immigrants in our city."

If the project is approved, the organization will work to foster agreements with city hall, including establishing projects to fight prejudice.

For Assis, a project like this shows the importance of integrating immigrants into society, rather than just regarding them as mere labor. "Projects like these can also contribute to a better initial experience for immigrants, to more intercultural exchanges, and as a consequence, less prejudice and xenophobia," she said.

Racism and xenophobia took on even more grotesque proportions on Oct. 17 last year in Navegantes, which is less than 12 miles from Balneário Camboriú. Fetiere Sterlin, a Haitian who arrived in Brazil in 2011 through a coyote network, died of stab wounds after a fight in Navegantes.

"This is an unacceptable xenophobic act. It shows hatred to others, the inability to live with differences. Even though the local authorities labeled it as a crime of passion, I would like to call attention to the possibility of it being a crime driven by racism and xenophobia," said Assis.

### Obama opens door to Democratic primary endorsement

President Barack Obama on Tuesday commented on the contentious Democratic primary race between Hillary Clinton and Vermont Sen. Bernie Sanders, acknowledging that Clinton aligns more with his policies.

"I suspect that on certain issues, she agrees with me more than Bernie does," Obama told reporters at a press conference in Rancho Mirage, California. "On the other hand, there may be a couple issues where Bernie agrees with me more. I don't know. I haven't studied their positions that closely."

Obama said he knows Clinton better than he does Sanders "because she served in my administration, and she was an outstanding secretary of state."

Clinton escaped Iowa with an extremely narrow win over Sanders but lost New Hampshire by 22 percentage points. Obama, however, noted that primaries are a time for candidates to try to distinguish themselves as he ticked off a list of principles Democrats converge around. "Bernie and Hillary agree on a lot of stuff and disagree pretty much across the board with everything the Republicans stand for," he said.

### Georgia state senator switches endorsement from Clinton to Sanders

The second-highest ranking Democrat in the Georgia state Senate on Tuesday switched his endorsement from former Secretary of State Hillary Clinton to Sen. Bernie Sanders.

In making the change, state Sen. Vincent Fort cited Sanders' positions on health care, Wall Street reform, and the minimum wage, according to the Atlanta Journal-Constitution's report.

"After months of looking at Bernie's record and studying his positions on healthcare, Wall Street, predatory lending and the minimum wage, I came to the conclusion that Bernie's position on the issues that affect my constituents in Georgia the most conform most closely to my positions," Fort said.

The decision by Fort, who is African-American, also means he's going against the state's Democratic establishment—including Atlanta Mayor Kasim Reed—which has mostly backed Clinton ahead of its March 1 primary.

The move comes during Sanders' current swing through the South ahead of the South Carolina Democratic primary on Feb. 27, as he looks to make inroads among the African-American electorate. On Tuesday, he held two campaign events in South Carolina and is scheduled to host another town hall at Morehouse College in Atlanta later in the day.

### State made earlier request for Clinton to hand over emails

The State Department in July 2014 unofficially requested that Hillary Clinton hand in copies of her work emails — much earlier than the late October 2014 date that has been cited by her presidential campaign and in court documents.

Conservative group Judicial Watch on Monday released a new email from Clinton's former chief of staff Cheryl Mills, where Mills is following up on what appears to be a request from Secretary John Kerry's chief of staff David Wade for hard copies of Clinton's messages.

"I wanted to follow up on your request last month

about getting hard copies of Secretary Clinton's emails to/from accounts ending in '.gov' for her tenure at the Department," Mills wrote to David Wade on Aug. 22, 2014 under subject line "following up."

"I will be able to get that to you, to the best of its availability. Given the volume, it will take some time to do but I wanted to let you know that I am working to get it to you," Mills continued.

The new batch of 189 documents, obtained through Judicial Watch's Freedom of Information Act lawsuit, show that State gave Clinton an informal request several months before the Department's official request for documents. Both State and the campaign have acknowledged that conversations on the issue had been going on before the official request was sent, but it has been unclear how early.

### Jesse Jackson: Sanders beating Clinton in tapping voters' 'pain nerve'

The way Jesse Jackson sees it, both Hillary Clinton and Sen. Bernie Sanders are tapping into the dissatisfaction that's energizing voters. Sanders is just doing it a bit better.

"She invokes her resume, which is what she has done. But there is a generation, say going from 1992, that has no recollection of that work. What they know is student loan debt as well as credit card right now," Jackson said in an interview with POLITICO Tuesday. "They're hurting from graduating with a diploma but no job right now. They know they are facing home foreclosures from bank behavior right now so that there is that."

Sanders is "hitting the pain nerve. That's what the essential reaction I'm getting from students who feel it." Clinton is doing it too, Jackson continued, "but not as effectively as Bernie's doing it--that's why he's getting the response he's getting."

Jackson praised both Democratic presidential candidates for focusing more on health care and civil rights as they campaign ahead of the Nevada caucus and South Carolina primary.

### George W. Bush returns to campaign trail to boost brother Jeb Bush

George W. Bush returned to the campaign trail on Monday for the first time since he left the White House, mounting a defense of his legacy and his brother Jeb's campaign after both were targeted by Donald Trump during the South Carolina Republican debate last weekend.

The former President issued a series of thinly-veiled attacks on Trump and touted his brother as a "steady hand" in a time of emerging national security threats.

"I understand that Americans are angry and frustrated but we do not need someone in the Oval Office who mirrors and inflames our frustration," George W. Bush told a crowd of 3,000 gathered in North Charleston. "We need someone who can fix the problems that cause our anger and frustration, and that's Jeb Bush."

George W. Bush never mentioned the Republican frontrunner's name, but the contrast he drew between "his big little brother" and Trump was obvious as he

defined "real strength" coming from "integrity and character."

### Marco Rubio says he wants to make up with Chris Christie

The U.S. senator from Florida says his staff has tried to make contact with the New Jersey governor — who dropped out of the presidential race after a poor showing in the New Hampshire primary — but has been unable to directly reach him.

Rubio said in a CNN interview on Sunday that he holds no grudge against Christie for the bruising GOP debate on Feb. 6 in which the governor relentlessly attacked the senator, calling him scripted and ill-suited to be president. Rubio stammered and repeated lines over and over again, prompting Christie to say in the televised debate that it was exactly the scripted response he was criticizing.

"We've tried to get ahold of him," said Rubio, who had a weak showing in the New Hampshire primary, something that was largely attributed to Christie's success in raising questions about him. "We're trying to set up a time to talk."

"I think he's taking a few days away from the grind," Rubio said. "And I understand that. I know we spoke to his staff."

Rubio, who ended up placing fifth place in New Hampshire after his less-than-stellar performance during the debate, said he does not blame the governor for his weak showing.

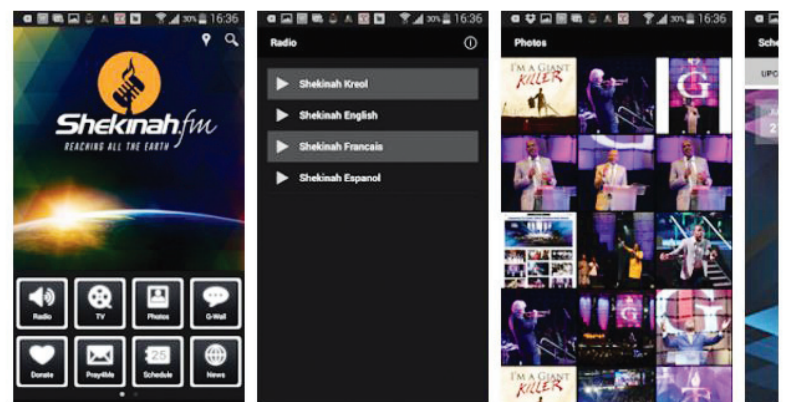

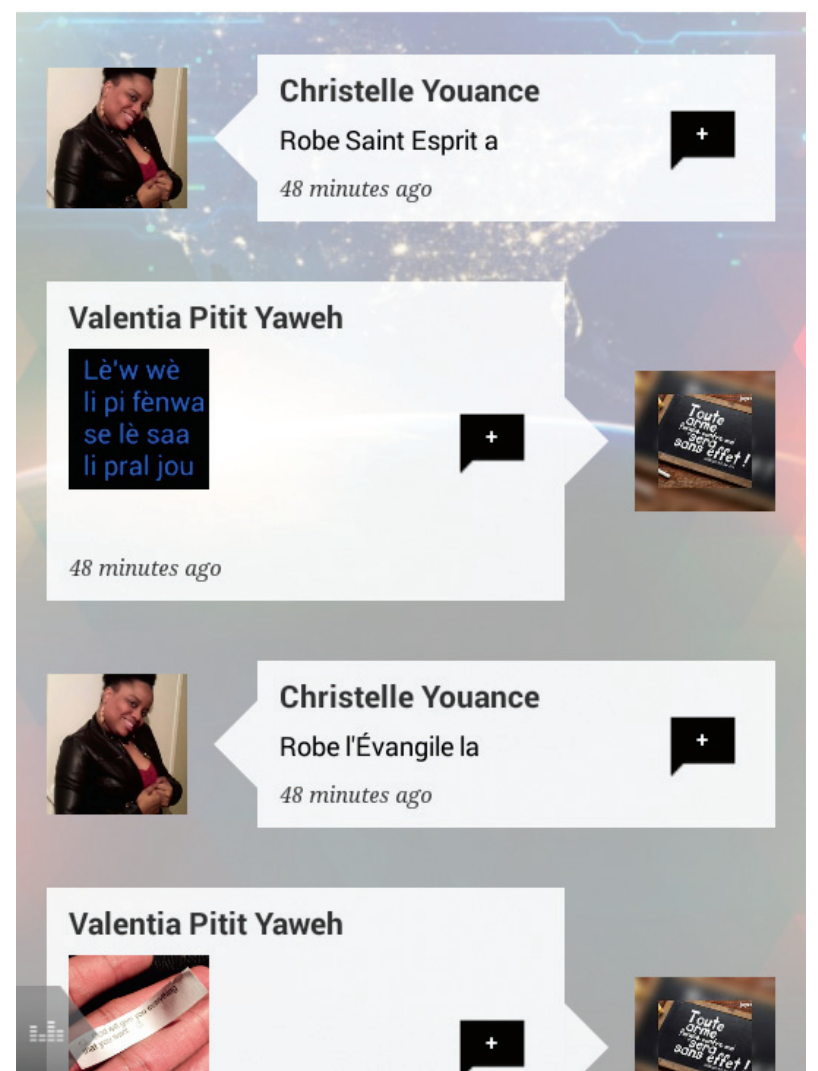

# Marie Holmes, \$188 Million Powerball Winner, Gets Sued By Pastor for NOT Paying \$10 Million Pledge to Church

Marie Holmes, North Carolina's \$188 million Powerball lottery winner is back in the news again.

This time Holmes is not spending \$21 million on bailing her boyfriend, Lamarr McDow, out-of-jail for the fourth time or harassing and threatening his side chick, but a pastor is allegedly suing her for \$10 million for reneging on a verbal contract.

The 27-year-old mother of two took home a \$127 million lump sum payment following her lottery win in February, 2015.

Pastor Kevin Matthews says he is experiencing emotional and mental distress due to her backing down from a verbal contract they had regarding \$1.5 million to purchase land to build a retreat facility.

"Because of the emotional distress and mental stress, they put me through, I had to start taking more medicine for anxiety and depression due to this situation," says Pastor Kevin Matthews.

Holmes' attorney, Ruth Sheehan, of The Francis Law Firm, said she was not aware of the situation or the lawsuit.

In a recent interview with EURweb, Pastor Matthews says: "God led him to her house and he prayed with her."

He later met Holmes and ministered to her on several occasions at her new home. He also said he ministered to three other people at her home, and then he eventually asked her to consider giving him money to purchase land to build a retreat. He gave her three different amounts that he needed (\$1 million, \$1.5 million and \$2 million). After several meetings, she agreed to give him \$1.5 million to help purchase land to build a retreat center that he says he had been praying about for years.

Matthews spoke to several realtors about the land and told them about the blessing he was receiving from Holmes, and he made a verbal contract to purchase the land. He says he even promised \$200,000 out to other people and their ministries over a two-year period.

Matthews says that eventually Holmes told him that her accountant, Dexter Perry, would be in touch and she did not know how long it would take because the money was in bonds. Matthews says Perry, called him and they talked for three hours about the matter and the conversation ended with the money would be available by the end of the year. After listening to the three-hour recorded information that Matthews provided EUR, it confirms Matthews' story

regarding Holmes supposedly giving money to him to purchase land for a retreat. Perry can be heard on the recording stating that Holmes' Foundation is being set up and that Holmes really wanted to help people out and that they will have her foundation, and everything set up soon and they will do it the right way.

On the last few minutes of the recording, Perry can be heard stating, "Well, I appreciate you allowing me to call and spend this amount of time with you this morning. I'm going to go ahead and email you as soon as we hang up. Just reply to that. I'm going to ask for a few things — if you just get that to me at your leisure." He goes on to say, "Like I said before, there's no need really to ask Marie anymore. She already said she wants to do something and now it's up to us to fulfill our strategy, and I definitely understand the urgency in terms of your land purchase and people calling you." The conversation ends with Matthews saying he wants to do what God wants him to do and help as many people as possible.

EURweb left a message for the accountant involved. His voicemail indicated he was out of the office. Holmes attorney, Ruth Sheehan, said she would give us a call back after speaking to Holmes, but as of this posting, has failed to do so.

"I didn't see this coming and I think it was a third party that came along and told her not to do this," says Matthews. Holmes started a foundation and appointed her aunt as the executive director, according to Matthews. At some point, Matthews says he believes her aunt, Carmel Wheaton, got involved and stopped her from sending him the money. He says, Wheaton called him and said, "We have decided not to give you money." He said he explained to Wheaton that Ms. Holmes said she was giving it and the accountant assured him as well. He said her argument was, "Did she promise it to you?" Matthews said, "I got caught up with trying to be truthful and said she didn't use the word 'promise.'" Matthews then quoted Wheaton as saying, "She was appalled that a pastor would even ask for money." Matthews contacted Holmes and she

would not return any calls. Holmes' boyfriend, Lamarr McDow (the one she ended up spending \$21 million on bailing out of jail) called him and said: "There was nothing ever written down so the best thing you can do is mind your business and Marie will mind her business." Matthews said he had prayed with McDow on several occasions and tried to help him clean up his life.

Asked if he had talked to Holmes lately and Matthews says he ran into her recently and she wouldn't speak to him. Interestingly, when asked for his attorney's name and contact information, Matthews would not

release the information. He says he is waiting on the paperwork (lawsuit) from his attorney.

"The bottom line ... I just want her (Marie Holmes) to do what she said she was going to do. I want peace and to do what God told me to do. I want her to do what she said she was going to do," says Matthews. "I really feel like a warrior for Christ and people need to be accountable."

Side note: Marie Holmes donated \$700,000 to her church, Pleasant Hill Missionary Baptist Church last December.

## Meurtre d'un patron haïtien: Amaral Duclona acquitté en appel

La cour d'assises du Val-de-Marne a acquitté vendredi Amaral Duclona, un chef de gang haïtien jugé en appel pour l'enlèvement, la séquestration et le meurtre d'un chef d'entreprise, Claude Bernard Lauture, en 2004 à Port-au-Prince.

Lors du premier procès, l'accusé, 34 ans, avait été condamné à 25 ans de réclusion avec une peine de sûreté des deux tiers. Jeudi l'avocate générale avait demandé une peine de 25 ans de

prison, estimant qu'il existait "suffisamment de preuves" qu'Amaral Duclona avait "participé à la détention et la séquestration de Claude Bernard Lauture". Elle avait également estimé que "l'ombre du pouvoir de (l'ancien président) Jean-Bertrand Aristide (avait) plané sur tout cet enlèvement".

Rappel des faits

Le 6 janvier 2004, ce chef d'entreprise franco-haïtien de 51 ans, opposé au régime d'Aristide, avait été enlevé par

# Haïti-Crise : Le G-8 se méfie d'éventuelles solutions cosmétiques

[AlterPresse] --- Le Groupe des huit (8) candidats à la présidence (G-8), qui conteste les résultats définitifs des élections du 25 octobre 2015, invite à se méfier des solutions cosmétiques, dans un communiqué en date du 15 février 2016, transmis à AlterPresse.

La procédure pour arriver à l'élection du président provisoire Jocelerme Privert, réalisée « en dehors du cadre constitutionnel », constitue une tentative de banalisation de la victoire du peuple haïtien du 22 janvier 2016 par les forces antidémocratiques, aux yeux du G-8.

Le sénateur Jocelerme Privert, âgé de 62 ans, a été élu par le parlement, à l'aube du dimanche 14 février 2016 (vers 4:00 am = 9:00 gmt), afin de combler le vide présidentiel, laissé par le départ de l'ancien président Michel Martelly à la fin de son mandat le 7 février 2016.

Cette élection a été suivie de la prestation de serment, la passation de l'écharpe présidentielle ainsi que de l'investiture de Jocelerme Privert, le même jour.

Les forces antidémocratiques ont été contraintes de faire marche arrière sur leur projet de

compléter un processus électoral bancal, ne respectant pas le verdict des urnes, rappelle le G-8.

Le G-8 souligne une volonté manifeste de faire avaler les résultats des élections de 2015.

Loin de constituer une simple crise de succession présidentielle, la crise actuelle est profonde et reflète le refus des masses défavorisées d'être exclues dans la vie politique du pays.

« Toute tentative, visant à forcer le peuple haïtien à accepter l'inacceptable, ne peut être qu'un élément irritant, susceptible d'aggraver la crise », analyse-t-il.

La solution à la crise passe, essentiellement, par la mise en place d'une commission d'enquête indépendante, composée de cinq membres désignés par des secteurs crédibles : l'association des médias, les droits humains, les organisations de femmes, l'Université et un groupe d'observateurs nationaux, estime le G-8.

Le Groupe demande d'approfondir l'évaluation, réalisée par la Commission d'évaluation

électorale indépendante (Ceei), et d'épurer le processus de vote par l'analyse des listes électorales partielles, des feuilles de comptage, des procès-verbaux, des bulletins de vote et des plaintes déposées, en vue de déterminer l'ampleur des irrégularités et des fraudes.

Il recommande d'identifier et d'exclure, du processus électoral, des bénéficiaires avérés des cas de fraudes, de réévaluer les décisions des Bureaux de contentieux électoraux départementaux (Bced) et de contentieux électoral national (Bcen).

Le G-8 appelle à confirmer les parlementaires, régulièrement élus, et à éjecter du parlement les parlementaires mal élus, tout en recommandant au gouvernement provisoire de consensus « toutes mesures jugées utiles et susceptibles de rétablir la confiance ».

Après l'investiture du nouveau président provisoire Jocelerme Privert, plusieurs secteurs politiques exigent du parlement le respect du principe de la séparation des pouvoirs, notamment dans la mise en place du gouvernement de consensus.

## Haïti-Politique : Mise en garde, au Plateau central, contre tout gouvernement-doublure de Martelly

Plusieurs bases de partis politiques au Plateau central mettent le parlement contesté en garde contre l'éventualité d'un nouveau gouvernement de doublure de Michel Martelly, pour remplacer l'ancien président tèt kale dans les prochains jours, selon les témoignages recueillis par AlterPresse.

Les membres de ces partis politiques, qui dénoncent l'accord intervenu, le 6 février 2016, entre Michel Martelly et les présidents du sénat et de la chambre des députés, Jocelerme Privert et Cholzer Chancy, ont fait valoir leur position, au cours de veillées patriotiques, dans la soirée du samedi 6 février 2016, en divers endroits à Hinche, chef-lieu du département du Plateau central.

Dans le même temps, ils demandent de retirer, de la prochaine course présidentielle, Jovenel Moïse, candidat du Parti haïtien tèt kale (Phtk) de Martelly.

« Jovenel Moïse, le poulain de Martelly, symbolise la continuité. De plus, il a été placé en première position, dans les résultats définitifs du premier tour de la présidentielle (le 25 octobre 2015), à la faveur de magouilles... non sanctionnées par le Conseil électoral décrié », arguent-ils.

Parallèlement, dans la soirée du samedi 6 février 2016, au centre de formation des cadres paysans à Papaye (à 7 km au nord-est de Hinche), les dirigeants du Mouvement paysan de Papaye (Mpp) ont organisé une veillée patriotique pour marquer la fin du règne de Martelly, propulsé au pouvoir, en 2011, par la communauté internationale.

Cette activité est nécessaire pour la consécration de la mort politique d'un homme (Martelly), qui a fait souffrir le peuple haïtien, estime le porte-parole adjoint de l'organisation paysanne, Philfrant Saint-Naré.

# Haïti : le parlement élit Jocelerme Privert président provisoire

Mais, au niveau de la chambre des députés, c'est Edgard Leblanc qui a eu le dessus avec une différence de 1 voix, car 46 députés ont voté pour lui et 45 autres pour Privert, alors qu'un autre a voté blanc.

Cette situation a forcé le bureau de l'Assemblée Nationale à organiser un autre tour qui a consacré la victoire de l'ancien directeur de la DGI et ancien ministre de l'intérieur.

Cette fois-ci, deux députés ont sauvé l'honneur de l'ingénieur Déjean Bélizaire en lui accordant leur vote. Celui-ci en effet n'en a obtenu aucun durant le premier tour.

Jocelerme Privert a donc récolté 64 voix parmi les députés et 13 parmi les pères conscrits (77 voix au total) et a pu prêter serment par devant l'assemblée après avoir démissionné comme sénateur et président du sénat.

Edgard LeBlanc Fils a obtenu 24 voix parmi les députés et 9 parmi les sénateurs. (33 voix au total). Belizaire Dejean a eu de son côté 2 voix parmi les députés et aucun parmi les sénateurs. Il y a eu 1 vote nul et 1 vote blanc.

L'ancien #1 de la Direction Générale des Impôts a pris officiellement le lendemain dimanche 14 février la succession de Michel Martelly, qui a achevé son quinquennat le 7 février sans transmettre le pouvoir à un président élu, à cause du report sine die du second tour de la présidentielle.

Le 57<sup>e</sup> président d'Haïti a indiqué que son mandat, prévu pour une durée de 120 jours, sera entre autres axé sur "le rétablissement de la sécurité intérieure, le rétablissement de l'état de droit, et la poursuite du processus électoral"

La cérémonie officielle de son installation s'est voulue inclusive en réunissant les différents secteurs de la vie nationale. Celle-ci s'est déroulée en présence notamment de représentants du gouvernement démissionnaire, du Haut état-major de la PNH, de membres de la classe politique, de représentants du corps diplomatique, du forum économique, de leaders religieux, des membres de la presse, de nombreuses personnalités du secteur Lavalas, dont l'épouse de l'ancien Président Aristide et la coordinatrice du parti Fanmi Lavalas, Dr. Maryse Narcisse, ainsi que de nombreux autres invités.



Le secteur lavalas était largement représenté à la cérémonie d'investiture du nouveau président provisoire Jocelerme Privert, en témoigne la présence de l'épouse de l'ancien Président Jean Bertrand Aristide, Mildred Trouillot Aristide (gauche) et la coordinatrice du parti Fanmi Lavalas, Dr. Maryse Narcisse (droite).

Le nouveau chef d'état qui a été ministre de l'intérieur sous le second mandat d'Aristide, a eu un message pour chacun des secteurs.

En 2004, après le départ en exil du président surnommé "Titid", Jocelerme Privert est arrêté et passe 26 mois en prison. Il sera libéré en 2006 après une grève de la faim. Il a signé son retour en politique à l'occasion des élections législatives de 2010.

Dans son allocution, le Président Privert a invité les fonctionnaires de l'état à s'acquitter de leurs tâches face aux multiples défis. Invitant la PNH et toutes les autres institutions à jouer pleinement leur rôle, Jocelerme Privert a mis l'accent sur le retour à la normalité constitutionnelle. " Nous sommes tous comptables de nos actes, nous sommes des apprentis de l'État de droit, " s'est exprimé le chef de l'État.

Plus loin, Privert a adressé de vifs remerciements à ses anciens collègues au Parlement qui lui ont témoigné de leur confiance en l'élevant à la dignité de Président provisoire de la République. M. Privert qui a salué également toutes les forces vives de la nation, n'a pas fait de promesse, comme ces prédécesseurs l'ont souvent fait. L'ancien législateur croit que l'Haïtien peut faire de grande chose. " Notre comportement citoyen de ces dernières semaines nous a convaincu que nous pouvons et devons étonner le monde par notre détermination, notre lucidité et surtout notre sens de la dignité humaine ", a-t-il avancé.

Tout en appelant au dialogue comme l'unique voie pour trouver une issue à la crise, le président provisoire a promis de prendre la loi mère comme boussole durant son administration. " Nous continuerons à nous efforcer de

respecter la constitution et les lois de la République, de protéger et de consolider les institutions républicaines, de veiller à la sauvegarde constante de l'intérêt général... ", a-t-il poursuivi en mettant l'accent sur la protection de la liberté, l'égalité et la fraternité qui constituent la pierre angulaire de la refondation de la citoyenneté des liens sociaux de l'état de droit.

Privert a eu des mots rassurants pour la Presse haïtienne, tournée en dérision durant le quinquennat de Michel Martelly. " La presse ne peut être sous presse, ni sous pression ", a lâché le chef de l'état provisoire qui a donné l'assurance que le rôle de la presse sera préservé et renforcé.

Le président par intérim a aussi prôné, la tolérance, la solidarité pour faire avancer le pays. " A une entente nationale, à un dialogue constructif, nous sommes tenus et vous êtes conviés ", tels sont les mots du président

de la République qui a profité de l'occasion pour tendre la main au secteur privé des affaires. " Je vous invite à mieux soutenir l'état, à payer vos impôts et nous saurons mieux vous soutenir... ", a promis M. Privert.

Aux abords du palais présidentiel, une cinquantaine de partisans Lavalas, parti de l'ancien président Aristide, ont manifesté leur joie de voir Jocelerme Privert à la tête du pouvoir exécutif.

"Lavalas reprend le pouvoir après 12 ans d'exclusion, qui ont été 12 ans de misère pour le peuple", explique Charles Lener, un portrait de Jean-Bertrand Aristide attaché à sa chemise. "Privert connaît lui les problèmes du peuple haïtien" assure-t-il.

Si l'élection du président intérimaire atténue la crise politique, l'incertitude persiste quant à la possible réalisation d'ici quatre mois des élections présidentielles et législatives partielles, reportées, ont noté de nombreux analystes politiques haïtiens.

## Moïse Jean Charles est vigilant face au nouveau président

Moïse Jean Charles, leader du parti *Pitit Dessalines*, assure que sa formation politique n'intégrera par le gouvernement de consensus. ## Les Etats-Unis et la France saluent l'élection de Jocelerme Privert

L'Ambassade des Etats-Unis salue l'élection par l'Assemblée Nationale de Jocelerme Privert comme Président Provisoire d'Haïti.

## L'UE souhaite l'aboutissement du processus électoral

L'élection, par les deux chambres réunies en

Assemblée Nationale, de M. Jocelerme Privert en tant que Président provisoire de la République d'Haïti dans les délais prévus par l'accord politique, montre la détermination des autorités haïtiennes à doter le pays d'institutions stables et légitimes à travers le dialogue et dans le calme et la sérénité.

L'Union européenne réaffirme son soutien aux efforts des autorités de transition dont la tâche principale sera l'aboutissement du processus électoral avec l'installation d'un nouveau Président élu par les citoyens haïtiens au plus tard le 14 mai et assurer ainsi la stabilité politique.

## Les parlementaires attendent la désignation du Premier Ministre

Les parlementaires sont dans l'attente des consultations en vue de la ratification d'un nouveau Premier Ministre. Les membres des différents blocs parlementaires réitèrent leur détermination à poursuivre l'application de l'accord du 6 février 2016.

Le sénateur Francisco Delacruz, (OPL), membre du bloc majoritaire au grand corps, souhaite que le président Jocelerme Privert lance dans le meilleur délai les consultations en vue de la formation d'un gouvernement de consensus et d'un nouveau conseil Electoral Provisoire (CEP).

Il soutient qu'il faudra au préalable identifier les secteurs qui devront désigner des représentants au sein de l'organisme électoral. De plus il attire l'attention sur la nécessité de former une commission indépendante d'évaluation du scrutin du 25 octobre. Il admet toutefois que le délai de 90 jours est relativement court pour réaliser les différentes étapes conduisant à l'intronisation du nouveau chef d'état le 14 mai 2016.

De son côté le sénateur Youri Latortue, chef de file du bloc minoritaire, insiste sur la nécessité d'une large participation des partis politiques dans le gouvernement de consensus. Il juge qu'il faut permettre aux partis impliqués dans les élections législatives et la présidentielle de disposer d'un représentant pour défendre leurs intérêts.

Il souligne également que le nouveau chef d'état devra publier les résultats des élections municipales afin de favoriser l'entrée en fonction des maires élus.

L'ex conseiller de Michel Martelly estime que la commission d'enquête électorale devra faire la lumière en vue de la réalisation du second tour de la présidentielle. Pour le sénateur Latortue la démarche consiste à compléter la présidentielle du 25 octobre.

Par ailleurs, le vice président du Sénat, Ronald Lareche, confirme que les parlementaires sont dans l'attente d'une initiative du chef de l'état pour lancer le processus de ratification d'un nouveau Premier

Ministre. Il rappelle que l'accord du 6 février stipule que le chef de l'état doit au préalable réaliser un dialogue avec les représentants des divers partis politiques, des organisations de la société civile, des secteurs patronales et syndicales en vue de déterminer le profil d'un rassembleur pouvant aider à rétablir la confiance des acteurs politiques.

## Jovenel Moïse exige un président constitutionnel dans 120 jours

Le candidat à la présidence du parti haïtien tet Kale (PHTK), Jovenel Moïse, a salué lors d'une conférence de presse, mardi 16 février, l'arrivée du président provisoire Jocelerme Privert à la tête du pays pour faciliter les élections. M. Jovenel Moïse a exigé que la date du 24 avril soit retenue pour que le pays ait un gouvernement constitutionnel le 14 mai prochain.

« Dans 120 jours, Haïti doit avoir un président constitutionnel et tout doit se faire par le peuple. Je tiens à féliciter le président au pouvoir Jocelerme Privert qui facilitera les élections dans le pays le 24 avril prochain, la publication des résultats pour le 6 mai et l'installation du nouveau président le 14 mai 2016 », a déclaré Jovenel Moïse qui invite le gouvernement provisoire à mettre en application les autres étapes de l'accord du 6 février dernier.

Le candidat du PHTK exige aux partisans de son parti de prôner la paix afin d'aider le gouvernement à assumer ses responsabilités et à organiser les élections dans un environnement serein et sécuritaire.

« Nous au PHTK, notre combat est pour renforcer et défendre la démocratie dans le pays pour permettre aux haïtiens d'être libre et de s'exprimer librement. Mais nous ferons tout ce qui est dans notre pouvoir pour faire respecter le vote du peuple. Et le parti est prêt à collaborer avec le pouvoir en place pour la bonne marche du pays », a martelé M. Moïse.

Ce dernier condamne aussi les actes de violence, d'intimidation subie par ses sympathisants au cours du processus électoral tout en saluant la mémoire de l'ancien candidat à la députation de Desdunes, Prévillon qui a été assassiné la semaine dernière. HPN

# Port-au-Prince : un carnaval national avalé par un climat socio-politique tendu

PORT-AU-PRINCE -- Il ne fait aucun doute que le carnaval est la plus grande manifestation culturelle en Haïti. Cette festivité donne lieu à un fabuleux moment où se mêlent toutes les couches de la société. Un grand moment de cohésion sociale qui permet de mettre en parenthèse les tracasseries quotidiennes, saison où les commerçants du secteur informel se tirent d'affaires et les membres de la diaspora en profitent pour se ressourcer en terre natale.

Les festivités carnavalesques 2016 (7,8 et 9 février) à Port-au-Prince déroulées sous le thème "Ayiti Toutan", avec comme sous-thème 'Tèt poze pour yon Ayiti pi fre', sont avalées par un contexte de grave crise politique, issue des élections controversées des 9 août et 25 octobre 2015

Cette situation socio-politique très préoccupante a démobilisé de nombreux acteurs importants, très inquiets en raison du contexte d'incertitude politique, marqué par l'approche tumultueuse de la fin de mandat, le dimanche 7 février 2016, de Joseph Michel Martelly à la présidence d'Haïti.

Martelly qui opta dans un premier temps de se maintenir au pouvoir jusqu'à l'élection d'un successeur démocratiquement a fini par abandonner ses intentions en remettant le pouvoir au par-

lement haïtien le dimanche 7 février 2016, date officielle marquant la fin de son quinquennat. Mais l'effet de ses ambitions de rester au pouvoir au-delà de cette date fatidique avait déjà fait planer un climat de peur, particulièrement sur la capitale haïtienne, haut lieu de rendez-vous du carnaval national pendant ces trois jours, à un moment où des sympathisants des partis de l'opposition se mobilisaient déjà dans les rues à travers des manifestations - souvent très violentes - pour forcer le désormais ex-président à démissionner.

Le secteur privé presque dans son ensemble - exceptée la compagnie de téléphonie mobile Digicel - s'est abstenu d'y prendre part. Les membres de la diaspora ont grandement brillé par leur

absence, et pas moins de deux grosses pointures (les groupes rivaux T Vice et Djakout #1) renommées pour leurs performances exceptionnelles sur le macadam ont décliné l'invitation du comité à participer.

En effet l'édition 2016 du carnaval de Port-au-Prince s'est déroulé dans un "format réduit", selon tous les constats. Le premier jour (dimanche gras) a été annulé pour raison sécuritaire à l'approche de la fin du règne de l'équipe Tet Kale au pouvoir. Sur les 500 meringues plus comptabilisées, seulement 7 formations musicales [ Kreyol La, Carimi, Boukman Ekspéryans, Rockfam, Barikad Crew, Mass Konpa et Bel Plezi ] ont pu animer le parcours durant ces deux jours.

Doté d'un maigre budget de 45 millions de gourdes, le comité ne pouvait pas faire grand-chose sans l'aide du secteur privé. Jusqu'à vendredi (5 février), le comité du carnaval avait reçu des demandes pour la construction de 60 stands, soit 50% de moins par rapport à la quantité de stands érigés dans l'air du Champs-de-mars en 'saison de paix socio-politique'.

Selon les propos de l'un des membres du comité sur la Télévision Caraïbes le deuxième jour gras, 3500 jeunes acteurs déguisés, regroupés au sein de plusieurs écoles de danse et autres institutions artistiques, ont produit du spectacle visuel sur tout le parcours pour le plus grand plaisir des spectateurs.

Ensuite, il précise qu'il a demandé à sa femme "son accord et elle était partante" pour qu'il parle en ces termes de Taylor Swift, qui elle-même fut prévenue et amusée de cette réplique. Selon Kanye West, c'est la jeune chanteuse qui aurait déclaré ne pas pouvoir "s'énerver contre Kanye, car il m'a rendue célèbre". 
